CONSTRUCTION TRAILER PERMIT APPLICATION

All contractors are required to have a current business license from a Georgia municipality!

\*Note: A separate permit is required for each and every trailer positioned on site. Separate permits are also required for utility connections.

Expiration of Permits: All permits expire 6 months after the last required inspection that has been passed, or 6 months after the date of issue if no required inspections have been approved.
