SWIMMING POOL PERMIT APPLICATION

All contractors are required to have a current business license from a Georgia municipality!

Expiration of Permits: All permits expire 6 months after the last required inspection that has been passed, or 6 months after the date of issue if no required inspections have been approved.

The pool coping, decking, or any attached part thereof shall be located no closer than (10) feet from any property line. The pool shall be enclosed with a Code approved fence or barricade, a minimum of 5 feet high, copy of which is attached.

All plumbing, gas and electrical and building work must be permitted separately and are not part of this permit.

Inspections must be approved on all building, plumbing and electrical work, including the required common equip-potential bonding grid and all its associated parts, prior to such work being covered by concrete, grout or fill material.

A final inspection is required after all the work is completed; the pool is filled with water and the pool barrier and its associated parts have been installed.
