COMMERCIAL DEMOLITION PERMIT

\*Note: A separate permit is required for each and every building or structure on which work is to be done. If building contains more than (1) unit, list addresses of all units in which work will be done.

All permits expire 6 months after the last required inspection that has been passed, or 6 months after the date of issue if no required inspections have been approved. The Building Official may issue a 6 month extension of any permit, (for due cause), if requested in writing by the permit holder prior to such a permit expiring.

- 1. NEED LETTER OF APPROVAL FROM OWNER OF PROPERTY
2. NEED APPROVAL FROM CITY OF ACWORTH HISTORIC PRESERVATION
3. NEED LETTER OF RELEASE FROM GAS COMPANY (Stating that the gas service has been "disconnected at the street")
4. NEED LETTER OF RELEASE FROM POWER COMPANY (Stating that the power service has been "disconnected at the street")
5. NEED LETTER OF APPROVAL FROM PUBLIC WORKS FOR EROSION CONTROL (770-975-0679)
